He loved baseball and hockey. After training at St Thomas, Trenton, and Uplands he was sent to BGS Jarvis. He was promoted Corporal. On the 3rd of Jan 1943 he was part of the crew in a test flight of Bollingbroke # 9964 that crashed shortly after take-off . He is buried in Mt Pleasant cemetery London Ontario.
