He sailed for England on the 18th of June 1916. After being transferred to the 75th battalion he was injured by shrapnel in his right eye and left thigh on the 12th of October 1916. His condition declined and he died the 27th of October in Rouen France. He was buried in St Sever Cemetery Extension Rouen France.






