**Summary:** Pte Robert Oscar Davis 803205 was killed by a shell explosion while sheltering in a shell hole on the 2 Sept 1918. He was a grocery clerk from Strathroy who signed up with in the 135th Btn on the 18th of May 1916. He was drafted to the 3rd Battalion in 14 Aug 1917. Beside his grave stone in the Dominion Cemetery at Hendecourt-Les-Cagnicourt France, his family erected a memorial to him in the Strathroy Cemetery.
