Summary: The son of Mr William Armstrong of Strathroy, and a clerk, attested in A Company of the 135th Btn on the 28th of July 1916 at Strathroy. He, as the Strathroy Age phrased it, died on his way to the Great War. He succumbed to pneumonia in Halifax on the 28th of August 1916. His body was returned to Strathroy and a large funeral, attended by his work mates from Rochester NY.


