He attested in the 70<sup>th</sup> Btn at London Ontario on the 1<sup>st</sup> Sept 1915 and transferred to the 5<sup>th</sup> CMR on the 14<sup>th</sup> of June 1916. He was killed in action on the 15<sup>th</sup> of August 1916. He is buried at Bedford House Cemetery West-Vlaanderen Belgium.




